

Contract for Husqvarna AB's returnable Packaging Pool.

This is a document that summarizes the requirements and regulations that apply to providers using Husqvarna AB returnable packaging. This document must be signed and dated by each supplier using the pallet pool.

Generally

Connection to the pallet pool.

The suppliers included in Husqvarna AB's returnable packaging pool are financially responsible for the empty packaging that is delivered, and responsible to confirm the delivery of empty packaging to the Husqvarna AB in the **Via Tracking system**. Suppliers are responsible and will be charged for lost or damaged packaging.

All suppliers who are selected to use Husqvarna packaging must use Via Tracking system.

Available packaging

The types of returnable packaging handled in Husqvarna AB's pallet pool are as follows:

- Pallet EUR-B 1200*800
- Collar 1200*800
- Lid 1200*800
- Pallet 600*800
- Collar 600*800
- Lid 600*800
- Corrogated Box 600*800*800
- Corrogated Box Lid 817*617*100
- Pla4 300*400*220
- Pla6 600*400*220

Note that approved use of the EUR / SJ-pallet is not to be handled in Husqvarna's pallet pool but by pallet transfer system (PTS).



Procedures

Ordering of packaging

When necessary, the supplier can order packaging via ViaTracking. The order shall be made no later than 5 working days before the expected delivery. The system displays only the packaging types that are relevant for each supplier.

The supplier is responsible for ordering packaging if necessary.

NOTE: When you order the packaging, it is in multiples. Ex 1 ½ stowage pallet = 13st pallets. If there is a lack of containers in pallet pool you are required to use alternative packaging with the same dimension.

When packaging is lacking in the pallet pool.

We have developed a disposable packaging (compensation cardboard container) together with Stora Enso packaging. This cardboard container will be used primarily when packaging shortage occurs.

These are referred to E4 and E6 that are replacements for the PLA4 and PLA6 containers.

E4= 400x300x200 E6= 600x400x200

The receiving of packaging

Upon receipt of the packaging, the supplier is obliged to acknowledge the packaging in Via Tracking. If the packaging is damaged, faulty or wrong quantity of packaging

this shall also be recorded in the system and correction will be made.

The Packaging can be damaged by moisture, such as wood and corrugated packaging, so we inform you that the packaging should be kept protected from such.

The sending of packaging

Upon sending the packaging with goods, the supplier is obliged to send the VT card with the delivery note.

If the notification are withheld or not inputted into the system, the supplier will be issued payment for that amount.

Internal use

Husqvarna packaging shall be used for Husqvarna articles. Husqvarna Packaging must not be used in the internal management of the supplier except



for the last operation and the delivery of the packaging. Packaging must not be used for external plants or supplied outside Sweden (except Milec Poland). Furthermore, we do not allow the supplier to have exorbitant quantities for storage. Husqvarna reserves the right to limit the ability to order additional containers for quantities request that are seemingly to be too high. The damaged packaging shall also be reported in Via Tracking. It should be reported in the system and then removed physically either by Husqvarna AB or by the supplier.

Delivery to another provider

All transactions between Husqvarna subcontractors shall be reported in Via Tracking. This means that the recipients must be registered in the system.

Needed packaging sent to another supplier shall be notified to Husqvarna and a decisions on suppliers that are included in the pallet pool approved and registered by Husqvarna AB only.

Delivery of Empty Packaging to Husqvarna AB

(This can occur when the supplier is no longer delivering to Husqvarna) Upon delivery to Husqvarna AB the transaction should be recognized in Via Tracking.

Do not forget to send with the delivery note. The packaging must be reported per delivery to the respective department of Husqvarna AB. The responsibility for the packaging transferred to Husqvarna AB when dispatch will be approved by the recipient.

If the notification is withheld or not inputted into the system, the supplier will be issued payment for that amount.

Inventory

At the request of Husqvarna AB, inventory of the empty packaging will be carried out. This should be done within 2 weeks from the request. If the inventory is not done within this time period, Husqvarna AB has the authorization to adjust the balance after own estimate. It is important that all the packaging associated with Husqvarna AB is inventoried and reported in Via Tracking. The inventory will take place and not to exceed two times per year. Husqvarna AB also owns the right to make visits to the supplier to check the handling and balances of the packaging.

Contact

If contact has been replaced, the data is changed in Via Tracking. This is done under user.
